## Official Drawing Rules Minnesota State Lottery 2025 Vikings Pre-Game Concert Event Giveaway September 14, 2025

The Minnesota Lottery (the "Lottery") will conduct a free-to-enter giveaway called the 2025 Vikings Pre-Game Concert Event Giveaway at the Vikings Pre-Game Concert on September 14, 2025. The Lottery will collect entries to enter into three (3) drawings.

1. To enter the drawing in the 2025 Vikings Pre-Game Concert Event Giveaway and be eligible to win, a player must: a) complete an official entry form in its entirety, including full name, U.S. Postal Service mailing address including zip code, date of birth, and phone number at the Lottery booth at the event, b) deposit the completed entry form into the official Minnesota State Lottery entry drawing box, and c) be at least 18 years of age. Each player may enter only once at each event. The official entry form is the only acceptable form of entry. Incomplete registration information may result in disqualification. A facsimile or photocopy of the entry form is not an eligible entry. Entries are void if mutilated or illegible. Specific event dates, drawing date, and prizes are in the table below.

- 2. Employees (including immediate family residing in the same household) of the Lottery, employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate and receive a prize from this drawing. Prizewinners will be selected and eligibility determined by the Lottery. The decision is final, binding, and conclusive in all matters.
- 3. The Lottery will conduct three (3) drawings.

Two (2) prizewinners will be drawn at random by a Lottery representative at approximately 3:00 p.m. at the U.S. Bank Stadium Plaza from all eligible entries received from 2:00 p.m. to 3:00 p.m. at the Vikings Pre-Game Concert event on September 14, 2025.

Two (2) prizewinners will be drawn at random by a Lottery representative at approximately 4:00 p.m. at the U.S. Bank Stadium Plaza from all eligible entries received from 2:00 p.m. to 4:00 p.m. at the Vikings Pre-Game Concert event on September 14, 2025.

One (1) prizewinner will be drawn at random by a Lottery representative at approximately 5:00 p.m. at the U.S. Bank Stadium Plaza from all eligible entries received from 2:00 p.m. to 5:00 p.m. at the Vikings Pre-Game Concert event on September 14, 2025.

A player may win only once in the Vikings Pre-Game Concert Event giveaway.

4. Five (5) prizes will be awarded.

The prizewinners from the first drawing on September 14, 2025 will each receive a signed Minnesota Vikings helmet, a Lottery and Minnesota Vikings co-branded T-shirt and hat, and \$50 in Minnesota Vikings scratch tickets. The taxable prize value is estimated at \$350. (Lottery-branded merchandise is valued at \$0.) If a selected prizewinner resides outside the state of Minnesota, they will receive \$50 cash, a signed Minnesota Vikings helmet, and a Lottery and Minnesota Vikings co-branded T-shirt and hat. The taxable prize value is

estimated at \$400. One (1) winner per household. The Lottery reserves the right to substitute prizes for any reason, including availability.

The prizewinners from the second drawing on September 14, 2025 will each receive a signed Minnesota Vikings jersey, a Lottery and Minnesota Vikings co-branded T-shirt and hat, and \$50 in Minnesota Vikings scratch tickets. The taxable prize value is estimated at \$450. (Lottery-branded merchandise is valued at \$0.) If a selected prizewinner resides outside the state of Minnesota, they will receive \$50 cash, a signed Minnesota Vikings jersey, and a Lottery and Vikings co-branded T-shirt and hat. The taxable prize value is estimated at \$500. One (1) winner per household. The Lottery reserves the right to substitute prizes for any reason, including availability.

The prizewinner from the third drawing on September 14, 2025 will receive an away-game trip for four (4) to the Green Bay Packers game on November 23, 2025 at Lambeau Field, Green Bay, Wisconsin, a Lottery and Minnesota Vikings co-branded T-shirt and hat, and \$50 in Minnesota Vikings scratch tickets. The trip will include round-trip airfare (if needed), transportation, hotel accommodation, football game tickets, and team-hosted events. Food and beverages will not be included. The taxable prize value is estimated at \$14,545.45. (Lottery-branded merchandise is valued at \$0.) If a selected prizewinner resides outside the state of Minnesota, they will receive \$50 cash, and an away-game trip for four (4) to the Green Bay Packers game on November 23, 2025 at Lambeau Field, Green Bay, Wisconsin, and a Lottery and Vikings co-branded T-shirt and hat. The taxable prize value is estimated at \$14,595.45. One (1) winner per household. The Lottery reserves the right to substitute prizes for any reason, including availability. **There is no cash option for the away-game trip prize.** 

- 5. The prizewinners will be announced on-site at the event; After the event, the prize will be shipped to the prizewinners at the address provided on their entry slip. If the prize is returned to the Lottery, the Lottery may declare the prize forfeited by the prizewinner, the prizewinner will have no further right to the prize, and the prize may be awarded to an alternate player.
- 6. Each player whose entry was selected to win a prize valued at \$600 or more must fill out and submit a Winner Affidavit form to the Lottery to claim the prize within five (5) days of being notified of winning. If the claim is not validated by the Lottery or the prizewinner fails to complete the Winner Affidavit Form, the claim will be denied, the prize will be forfeited, and the player will be notified immediately.
  - For the away-game trip, if the prizewinner is delinquent in the payment of
    Minnesota state taxes or owes a debt as defined in Minn. Stat. § 270A.03, subd. 5,
    the prizewinner will be given seven (7) calendar days from the date the Lottery
    informed them of the existence of a debt to fully satisfy the debt, as determined by
    the Minnesota Department of Revenue. If the prizewinner fails to completely
    satisfy the debt within seven (7) days, the away game trip and lottery prize pack will

be forfeited and the debt will not be repaid. There is no cash option for the awaygame trip prize.

- 7. The Lottery will draw ten (10) alternate entries on-site and prizes will be awarded to the first available alternate based on availability of prizes. If necessary, prizes will be awarded to alternates in the order drawn.
- 8. By entering this giveaway, prizewinners consent to full use of any and all information they provide on their entry form for publicity, public relations, and content creation purposes, including on Lottery social media channels and mnlottery.com, by the Lottery. Prizewinners may be required to execute a Winner Affidavit form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.
- 9. Odds of winning will be determined by the total number of entries received.
- 10. Unless otherwise stated, no cash equivalents will be awarded. Prizes are not exchangeable or otherwise transferable. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.

The Lottery, The Minnesota Vikings, and/or any of their affiliated entities are not responsible, in any way, for any personal injuries, death, property damage, or other damages or expenses resulting from or arising out of any acceptance, fulfillment (including shipping and handling), installation, operation, loss, or misuse of the prize and/or any element thereof. All other costs and expenses related to acceptance and use of any element of the prize not specified herein as being provided may be the sole responsibility of prizewinner, including, without limitation, any fees, costs, and/or taxes related to the 2025 Vikings Pre-Game Concert, or transportation to and from US Bank Stadium Plaza, Minneapolis, MN, or Lambeau Field, Green Bay, Wisconsin.

If, for any reason it is not possible to run all or any part of the 2025 Vikings Pre-Game Concert Event Giveaway as planned due to, without limitation, errors in these official rules or advertising for this giveaway, tampering, unauthorized intervention, fraud, technical failures, human error, or any other cause beyond the control of the Lottery that, in the sole judgment of the Lottery, could corrupt or affect the administration, security, fairness, integrity, or proper conduct of this giveaway, the Lottery reserves the right at its sole discretion, to cancel, terminate, modify, or suspend the giveaway.
