Official Drawing Rules Minnesota State Lottery Back to the Patio Online Giveaway June 19, 2025–July 15, 2025

- 1. To enter and be eligible to win, a player must:
 - A. be eighteen (18) years of age or older
 - B. have a registered account on and be logged in at <u>mnlottery.com</u> or on the Minnesota Lottery mobile app
 - C. have completed the entire address portion with their complete U.S. Postal Service mailing address, including zip code, in the sign-up area (used only for mailing any prize won)
 - D. have an account registration address within Minnesota or one of the four (4) states bordering Minnesota (North Dakota, South Dakota, Iowa, or Wisconsin)
 - E. Submit an entry in the Back to the Patio Online Giveaway between 9:00:00 a.m. on June 19, 2025, and 11:59:59 p.m. on July 15, 2025 (any answer selected before submitting an entry has no bearing on the giveaway outcome)
- 2. Each player may enter only once.
- 3. The Lottery is not responsible for delayed, lost, or misdirected electronic submissions made through the Internet.

5. The Lottery will conduct one (1) drawing.

The first five (5) prizewinners drawn will each receive \$35 in Minnesota Lottery scratch tickets, one (1) outdoor Bluetooth speaker, two (2) Lottery-branded scratchers, one (1) Lottery-branded hammock, one (1) Lottery-branded four-piece coaster set, one (1) Lottery-branded can cooler, one (1) Lottery-branded size XL T-shirt, one (1) Lottery-branded cooler bag, and one (1) Lottery-branded wander cushion. The taxable prize value is estimated at \$21.99 (Lottery-branded merchandise and scratch tickets are valued at \$0).
