## Official Drawing Rules Minnesota State Lottery Minnesota State Fair Free Chance to Win Online Giveaway August 21, 2025–September 1, 2025

- 1. To enter and be eligible to win, a player must:
  - A. be eighteen (18) years of age or older
  - have a registered account on and be logged in at <u>mnlottery.com</u> or on the
     Minnesota Lottery mobile app
  - C. have completed the entire address portion with their complete U.S. Postal Service mailing address, including zip code, in the sign-up area (used only for mailing any prize won)
  - D. have an account registration address within Minnesota or one of the four (4) states bordering Minnesota (North Dakota, South Dakota, Iowa, or Wisconsin)
  - E. Submit an entry in the Minnesota State Fair Free Chance to Win Online Giveaway between 9:00:00 a.m. on August 21, 2025, and 11:59:59 p.m. on September 1, 2025 (any answer selected before submitting an entry has no bearing on the giveaway outcome)
- 2. Each player may enter only once.
- 3. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the "Lottery"), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate and receive a prize from this Minnesota State Fair Free Chance to Win Online Giveaway. If the prize is not claimed via email or is returned to the Lottery, the Lottery may declare the prize forfeited by the prizewinner, the prizewinner will have no further right

to the prize, and the prize may be awarded to an alternate player. The Lottery is not responsible for delayed, lost, or misdirected electronic submissions made through the Internet.

5. The Lottery will conduct one (1) drawing.

The first prizewinner drawn will receive \$500 cash, one (1) Lottery-branded T-shirt, one (1) Lottery-branded pair of sunglasses, one (1) Lottery-branded beach towel, one (1) Lottery-branded reusable straw with case, one (1) Lottery-branded canvas grocery tote, one (1) Lottery-branded tumbler, one (1) Lottery-branded folding reusable tote, and one (1) Lottery-branded metal can cooler.
