Official Drawing Rules Minnesota State Lottery Mystery Sur-Prize Online Giveaway September 25, 2025–November 2, 2025

- 1. To enter and be eligible to win, a player must:
 - A. be eighteen (18) years of age or older
 - have a registered account on and be logged in at <u>mnlottery.com</u> or on the
 Minnesota Lottery mobile app
 - C. have completed the entire address portion with their complete U.S. Postal Service mailing address, including zip code, in the sign-up area (used only for mailing any prize won)
 - D. have an account registration address within Minnesota or one (1) of the four (4) states bordering Minnesota (North Dakota, South Dakota, Iowa, or Wisconsin)
 - E. Submit an entry in the Mystery Sur-Prize Online Giveaway between 9:00:00 a.m. on September 25, 2025, and 11:59:59 p.m. on November 2, 2025 (any answer selected before submitting an entry has no bearing on the giveaway outcome)

If the prize is not claimed via email or is returned to the Lottery, the Lottery may declare the prize forfeited by the prizewinner, the prizewinner will have no further right to the prize, and the prize may be awarded to an alternate player. responsible for delayed, lost, or misdirected electronic submissions made through the Internet.

 - The first prizewinner drawn will receive \$50 in Minnesota Lottery scratch tickets and one (1) Lottery-branded size XL long-sleeve shirt. The taxable prize value is estimated at \$0 (Lottery-branded merchandise and scratch tickets are valued at \$0).
 - The next prizewinner drawn will receive \$30 in Minnesota Lottery scratch tickets and one (1) Lottery-branded size large "ugly" holiday sweatshirt. The taxable value is estimated at \$0 (Lottery-branded merchandise and scratch tickets are valued at \$0).

The taxable value is estimated at \$0 (Lottery-branded merchandise and scratch tickets are valued at \$0).
 - The next prizewinner drawn will receive \$10 in Minnesota Lottery scratch tickets, one (1) Lottery-branded size XL T-shirt, one (1) Lottery-branded can cooler, and one
 - (1) Lottery-branded tumbler mug. The taxable value is estimated at \$0 (Lottery-branded merchandise and scratch tickets are valued at \$0).
 - One (1) prizewinner per household.

If any prizewinner resides outside of Minnesota, their scratch ticket prize will be converted to cash. The Lottery reserves the right to substitute prizes for any reason, including availability. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.
