## Official Rules Minnesota State Lottery National Get Outdoors Day Social Sweepstakes Saturday, June 11, 2022

- 1. To be eligible to win a player must:
  - A. be a registered member of Facebook (<u>www.facebook.com</u>);
  - B. be eighteen (18) years of age or older;
  - C. be a resident of the state of Minnesota with a Minnesota U.S. Postal Service mailing address;
  - D. have commented I'MN on the Minnesota Lottery Facebook National Get Outdoors Day Social Sweepstakes page between 12:00 a.m. central time ("CT") on Saturday, June 11, 2022, and 11:59 p.m. (CT) on Saturday, June 11, 2022.
- 2. Any entry or portion of an entry that demeans, defames, or ridicules others, contains profanity or illegal activity, or is not in the best interest of the Minnesota Lottery or its marketing may be deleted and disqualified from this Social Sweepstakes.
- 3. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the "Lottery"), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate or receive a prize from this sweepstakes.

The approximate taxable prize value is \$0. The Lottery reserves the right to substitute or omit prizes for any reason, including availability. A prizewinner may win only once. One (1) prizewinner per household. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.
- 6. The Lottery, and/or any of its affiliated entities is not responsible, in any way, for any personal injuries, death, property damage, or other damages or

- expenses resulting from or arising out of any acceptance, fulfillment (including shipping and handling), installation, operation, loss, or misuse of the prize and/or any element thereof. All other costs and expenses related to acceptance and use of any element of the prize not specified herein as being provided are the sole responsibility of the prizewinner.
- 7. The Lottery will request personal information to validate each prizewinner. Incomplete information may result in entry disqualification. If the Lottery is unable to validate a winning entry, the Lottery will deem it ineligible and the player will not be entitled to any prize.
