Official Rules Minnesota State Lottery Shopping Spree Social Sweepstakes Thursday, November 9, 2023

- 1. To be eligible to win a player must:
 - A. be a registered member of Facebook (www.facebook.com);
 - B. be eighteen (18) years of age or older;
 - C. be a resident of the state of Minnesota with a Minnesota U.S. Postal Service mailing address;
