Official Rules Minnesota State Lottery Back to the Fair Social Sweepstakes Friday, August 8, 2025

- 1. To be eligible to win a player must:
 - A. be eighteen (18) years of age or older;
 - B. be a registered member of Facebook (<u>www.facebook.com</u>);
 - C. be a resident of the state of Minnesota with a Minnesota U.S. Postal Service mailing address;
 - D. have commented "I'MN" and tagged a friend in the comment on the Minnesota Lottery Facebook Back to the Fair Social Sweepstakes post between 12:00 a.m. central time ("CT") on Friday, August 8, 2025, and 11:59 p.m. (CT) on Friday, August 8, 2025.
- 2. Any entry or portion of an entry that demeans, defames, or ridicules others, contains profanity or illegal activity, or is not in the best interest of the Minnesota Lottery or its marketing may be deleted and disqualified from this Social Sweepstakes.

Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the "Lottery"), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate or receive a prize from this sweepstakes.
